This qualification framework has requirements for levels 5, 6 and 7 of European Qualification Framework.

ISHCCO's intent, in cooperation with international associations, universities and training institutes is to offer a comprehensive and practical support to assist the coordinators in their daily professional activities. ISHCCO members are encouraged to use the qualification framework as standards for safety and health construction coordinators.

This cooperation facilitated by ISHCCO will make its members stronger while maintaining diversity.

### ***Services***

In cooperation with the representatives of the various member countries ISHCCO provides recommendations to improve a better qualification and improved performance of the safety and health construction coordinators given the national and European legal frameworks. ISHCCO also endorses the introduction of new processes and tools based on the digital transformation occurring in the society and in construction. It is a relentless effort envisaging the continuing improvement of the safety and health construction coordination.
