


#### ISHCCO

Qualification Framework (IQF) (1)

- 1992: Directive 92/57/EEC introduced SHCCCs defining their duties.
- 2010: EC "Non-binding Guide for Construction Sites Directive" include Good practice for SHCC's Qualifications
- ISHCCO & others identified the need for a uniform standard for SHCC
- IQF: based on European Qualification Framework (EQF)
- IQF: In line with Good Practice of EC "Non-binding Guide for Construction Sites Directive"
- IQF: Published in 2015 (A+A, Dusseldorf) -Amendment in 2022 to include Vision Zero Strategy and Sustainable Development Goals (SDGs)













### ISHCCO

#### Qualification Framework (IQF) (2)

- Required Knowledge & Skills, Responsibility and autonomy
- At three EQF Levels for Project preparation & execution stages (duties, project examples and job names)
  - 5: technicians: small projects
  - 6: Expert Technicians &
  - 7: Engineers Professional Managers: complex projects.
- They emphasize the importance of understanding the design process and interface risks between construction techniques – supported by EC non-binding Guide
